## ABOUT THE AUTHORS

**Ahmad Atif AHMAD** is Assistant Professor of Religious Studies at Macalester College. He taught at Cairo University (1994–1997) and Harvard University (1999–2005). His recent publications include “Structural Interrelations of Theory and Practice in Islamic Law” (2006) and “The Evolution of Just War Theory in Islamic Law” in *American Foreign Policy Interests* 28, no. 2 (April 2006).

**Holly R. BARCUS** joined the Macalester College faculty as Assistant Professor of Geography in 2005. She is broadly trained, teaching population geography and introductory and advanced Geographic Information Systems (GIS) courses. Her research interests fall at the intersection of population and GIS. She is specifically interested in the patterns and processes of change occurring in rural communities and the resulting migration, service provision, and housing dilemmas. Her recent research projects focus on the changing racial and ethnic composition of rural places and the implications for rural population growth, planning, and development.

**Terry BOYCHUK** is Associate Professor and Chair of the Sociology Department at Macalester College. His research and teaching interests span the fields of comparative-historical sociology, political sociology, sociology of the welfare state, and the sociology of nonprofit organizations. His book, *The Making and Meaning of Hospital Policy in the United States and Canada*, is a comparative history that explains why movements for national health insurance have failed in the U.S. and flourished in Canada. He is now researching the historical transformation of American philanthropy in the 19th and 20th centuries.

**CHEN Shin-Horng** earned his Ph.D. in the ICT program and economic geography, Centre for Urban and Regional Development Studies, University of Newcastle upon Tyne. He joined Chung-Hua Institution for Economic Research in Taiwan in 1995. He is currently a research fellow and the director of the International Division. His research addresses economic and policy issues on ICT and S&T policy as well as industrial economics. His major publications can be found in the journals *Research Policy*, *Industry and Innovation*, *Taiwan Academy of Management Journal*, and in a number of edited books.

**Allen CHUN** is a Research Fellow in the Institute of Ethnology, Academia Sinica, Taiwan. His research interests include socio-cultural theory, national identity, and (post)colonial formations. Most of his empirical work has dealt with Chinese-speaking societies (contemporary and late traditional). In addition to a recent book, *Unstructuring Chinese Society: The Fictions of Colonial Practice and the Changing Realities of ‘Land’ in the New Territories of Hong Kong* (2000, 2002), he edited a special double issue in *Cultural Studies* 14 (3–4) entitled, “(Post)colonialism and its Discontents”; a special issue in *Social Analysis* 46 (2) entitled, “Global Dissonances,” and co-edited a book entitled, *Refashioning Pop Music in Asia: Cosmopolitan Flows, Political Tempos and Aesthetic Industries*.

His major papers have appeared in diverse journals, including *Theory, Culture & Society*, *boundary 2*, *History and Anthropology*, *Ethnic and Racial Studies*, *Current Anthropology*, *Journal of Historical Sociology*, *Anthropological Theory*, *Cultural Anthropology*, *Journal of Postcolonial Studies*, *Social Analysis*, *Communal/Plural*, *Inter-Asia*, *Late Imperial China*, and *Toung Pao*.

**Shu GAO** studied in the Department of Geography, Nanjing University, receiving his B.Sc. in 1985 and M.Sci. in 1988. He then served as a Research Assistant at the Second Institute of Oceanography, State Oceanic Administration of China. In 1993, he obtained his Ph.D. in the Department of Oceanography, University of Southampton, U.K. He was a Research Fellow at Southampton Oceanography Centre, U.K., from 1993–1996, and a Research Professor, Institute of Oceanology, Chinese Academy of Sciences, from 1996–2000. Now a Professor in Marine Geology and Physical Geography, School of Geographic and Oceanographic Sciences, Nanjing University, he has published 140 research papers in refereed scientific journals, and 30 articles as book contributions.

Dr. Jing earned his B.A. in Chinese literature and language from Sichuan University in 1983. In 1986 he received his M.A. from Nanjing University, where he studied with Qianfan Cheng. He earned his Ph.D. in Chinese literature from Nanjing University in 1997. His research is focused on Chinese fiction. He has published more than 40 academic articles, including “Buddhism and Novels in the Tang Dynasty,” “On Yingying’s Story,” “Luxun: A Man who was Against the Power.” He has also translated Eastern European novels, such as Milan Kundera’s *The Farewell Party*, *The Joke*, and *Life is Elsewhere*, as well as Ivan Klima’s *The Spirit of Prague* and *My Merry Morning*.

**Gary KRUEGER** is Professor and Chair of Economics at Macalester College. He earned his B.A. at the University of Illinois–Champaign in 1981, and his M.S. and Ph.D. at the University of Wisconsin–Madison in 1986 and 1989, respectively. His interests include comparative economic systems, the transition to market economy in Eastern Europe, industrial organization, and applied econometrics.

He is the author of ten books on modern Chinese history, most recently *Mao Zedong: A Political and Intellectual Portrait* (2006). His writings on China have been translated into Chinese, Korean, Japanese, French, Italian, German, Spanish, and Portuguese.

**Weiwen MIAO** is Associate Professor of Mathematics and Computer Science at Macalester College. Her research interests are non-parametric statistics and the use of statistics in the legal system. She has published papers on how to properly analyze the data sets from actual law cases, and how to modify the existing methods to accommodate different kinds of data. **Vasant A. SUKHATME**, a Macalester College faculty member since 1978, is the Edward J. Noble Professor of Economics. His teaching portfolio consists of intermediate and upper-level courses in microeconomics and economic development; he also regularly offers a course on the economics of Adam Smith and Karl Marx. His main professional writing has been in the area of agricultural development, while also contributing to the literature on assessing the impact of economic assistance to low-income countries. In addition, he has written on the economics of tennis. He received Macalester's Excellence in Teaching

Award, and the Thomas Jefferson Award for overall contributions to the College.

**Yue-him TAM** taught at Bowdoin College and the Chinese University of Hong Kong before moving to Macalester College, where he is Professor of History. He has published widely in Chinese, Japanese, and English on modern China and Japan. His research interests are in the intellectual history of modern East Asia, Sino-Japanese relations, Asian American issues, and war crimes in contemporary Asia.

One of the first scholars to look extensively at “low” Russian culture, **James VON GELDERN** is the author of *Bolshevik Festivals, 1917–1920*, a study of how elaborate socialist festivals helped build a new political culture in the U.S.S.R., and the co-editor of two complementary anthologies of popular culture, *Mass Culture in Soviet Russia: Tales, Poems, Songs, Movies, Plays and Folklore, 1917–1953*, and *Entertaining Tsarist Russia: Urban Entertainments, 1798–1917*. His most recent project is a website called Seventeen Moments in Soviet History ([www.soviethistory.org](http://www.soviethistory.org)), compiled with Lewis Siegelbaum of Michigan State University, and recipient of the prestigious MERLOT Classic Award for 2006. Von Geldern is also a practicing human rights lawyer, specializing in asylum claims in the U.S. He teaches in the Russian and International Studies programs at Macalester; in the latter program he focuses on human rights and international law.

**WANG Horng-luen** received his Ph.D. at the University of Chicago and is currently an Associate Research Fellow at the Institute of Sociology, Academia Sinica, Taiwan. His research interests include social theory, cultural analysis, and political sociology. Centering around the interrogation of modernity, the topics he has studied range from the interplay between nationalism and globalization, the construction of national culture, the politics of language, and state sovereignty, to visas and passports. In addition to the nationalist politics in Taiwan, his recent research scope is extended to China and Japan with regard to the relations between emotions, national identities and war. His works have appeared in journals such as *Theory, Culture & Society*, *Comparative Study of Society and History*, *Identities: Global Studies in Culture and Power*, and *Social Analysis*, among others. He was a recipient of Wu Ta-you Memorial Awards, granted by the National Science Council (Taiwan) in 2005.
