*Water Management Issues Seminar

A three-day "Water Management Issues" seminar was held in Kathmandu, July 31 - August 2. The seminar was hosted by the Agricultural Projects Services Centre (APROSC) and supported by the Agricultural Development Council. Attendance and participation were enthusiastic with between 90 and 120 participants at each of the sessions.

Participants were invited from the Department of Irrigation, Department of Agriculture, National Planning Commission, Water Resources and Energy Commision, Ministry of Panchayat and Local Development, Agricultural Development Bank, international donor agencies, PVO's, and consulting Cornell University professors Randolph Barker, Gilbert Levine, and Norman Uphoff were resource persons under the sponsorship of USAID's Water Management Synthesis II Project. Three papers were presented the first day. A paper on "Irrigation and Water Management Issues" was presented by Bharat Bahadur Pradhan, Edward Martin, Robert Yoder, and Dr. Prachanda Pradhan. Professor Gilbert Levine presented a paper on "The Asian Context for Irrigation," and Dr. Takur Nath Pant, director of APROSC, and Jyoti Lohani, APROSC, presented a paper on "Some Observations on Irrigation Development in Nepal."

Three half-day technical sessions discussed (1) Water management in the Context of Irrigation Development, (2) Institutional Linkages in Water Management, and (3) Community Irrigation Management. Recommendations from these sessions were presented and discussed in a final general session. The seminar's opening address and closing remarks were made by Dr. Mohan Man Sainju, Vice-Chairman, National Planning Commission. Proceedings of the seminar will be published by APROSC.
