I. NEWS

***NEPAL AND HIMALAYAN EVENTS AT THE TWELFTH ANNUAL SOUTH ASIA CONFERENCE, MADISON, November 4-6, 1983.**

The Nepal Studies Association held its annual meeting in conjunction with the Conference again this year. In addition to the business meeting, panels were presented, documentary films were available for viewing in the film room, a roundtable discussion was held, & a Nepali Potluck Buffet dinner was held. The American Nepal Education Foundation also had some of its grantees present from various campuses. Krishna Pradhan, Univ. of Wis-Madison, organized a Nepali "Gyana-Goshthi" for the sharing of research.

Three panels focused on the Himalayas: "Economy, Exchange and Culture in the Himalayas" and "The Nature of Tibetan Polity: Some Aspects of Business and Entrepreneurship in Tibet, Parts III and IV" (Parts I and II were held in 1980). In addition, there was a roundtable discussion of the book Nepal Mandala by Mary Shepherd Slusser.

In addition to the panels, Dor Bahadur Bista, head of the new Department of Anthropology and Sociology at Tribhuvan University, gave a special lecture on November 3 at the University of Wisconsin-Madison. "Current Perspectives on the People of Nepal."

A video tape room offering continuous showings of 11 video-cassettes opened for the day on Saturday morning in addition to the film room which showed 14 documentary films, none of which had ever been shown at a Wisconsin Conference before. Among the Nepal Himalaya events were two films. One was "The Fragile Mountain", a Sandra Nichols Production originally broadcast on PBS's Nova Series in October of 1982. The other was "The Kafir Kalash of the Hindu Kush," by Margaret Fairlie Kennedy. In addition, Linda Iltis, Univ. of Wis-Madison, gave a video lecture on "Women's Roles in Newar Ritual: The Swasthani Vrata" which tied in with videocassettes by Ter Ellingson and which was based on research and documentation conducted in the Kathmandu Valley from 1981-83.

A variety of exhibits and displays provided interest, color and education in the Lowell Hall Conference Headquarters. "Bhutan, The Dragon Country" by Kathleen Frey, Univ of Wis-Madison, was an exhibit of Bhutanese textiles, artifacts & photos that depicted the lifestyles of the Bhutanese. Two films, supplied by the Permanent Mission of Bhutan to the UN, were available on Bhutan in the film room to accompany this exhibit. Another exhibit was "Possession & Healing in a Brahmin Chhetri Village in the Kathmandu Valley", a display of colored photos by Al Pach, Univ of Wis-Madison, and Heidi Larson, Sheldon Travel Fellow, Harvard Univ, done in the winter of 1983. The display follows as a spirit-inflicted illness is diagnosed by the clan deity and guru in a Nepal village. And finally, "Nepal Mandala", an exhibit of photos, drawings and an oil painting from the book Nepal Mandala was on display in the Main Lounge Area, along with a presentation of slides taken during the research for the book.

***MINUTES OF THE ANNUAL MEETING OF THE NEPAL STUDIES ASSOCIATION-NOV. 4, 1983**

12th Annual Conference of the South Asia Area Studies Center,
University of Wisconsin at Madison (Nov. 4-6, 1983)

The meeting was called to order at 12:05 p.m. with words of welcome by Ronald M. Bernier, President, and special reference to the presence of Dor Bahadur Bista, Honorary President, visiting from the Department of Sociology and Anthropology at Tribhuvan University, Nepal. Also especially noted was the presence of Mary Shepherd Slusser as conference guest to mark the publication of her two-volume book Nepal Mandala (Princeton, 1983).

Minutes of the 1982 Annual Meeting, also in Madison, were summarized, with notation that the person elected to be vice-president had withdrawn. Treasurer Linda Stone and Secretary Krishna Pradhan continue in office, as does the president.

Treasurer's report submitted by Linda Stone through Kathryn March was read, with total Nepal Studies Association treasury near \$5000.00 at present. Special recognition was made of substantial support for publication being provided by Cornell University and its South Asia Program. Subscription and membership costs currently cover 2/3 of the bulletin costs.

A report on the status of the Himalayan Research Bulletin submitted by Kathryn March was read (with explanation of the absence of March and Holmberg due to illness). With the Monsoon issue of 1983, membership totalled over 300, including individuals and institutions. Membership rosters have been monitored closely, so that complimentary promotional mailings are kept to a minimum and dues paying is regularized. The yearly contribution by Cornell is approximately \$4500.00 and the funds raised by dues approximately \$3000.00 — ideally, these two sources of income should be reversed for sound future planning. A computer mailing list has been created and is working well, and student aid has been providing substantial help thanks to Cornell University funding. The special issue in honor of Prof. John Hitchcock is proposed to appear in Monsoon, 1984 and Maureen Durkin-Longley has agreed to be the editor for that number. Plans are being made to further improve the bulletin, both in terms of its length and variety of its content. It will continue to appear three times yearly. There is still need for regular correspondents throughout the Himalaya (Kashmir, Himachal Pradesh, Pakistan, Bhutan, Sikkim as well as Nepal) and volunteers are requested to contact the editors, David Homlberg or Kathryn March. And it is not too early to take suggestions regarding future editor(s) and future institutional support.

Concerns that are essential to planning ahead include making every effort to secure tax-exempt status for the association, and for an eventual endowment which would draw interest as a foundation for future publication and activities. Matching support could be sought from U.S.A.I.D., National Science Foundation, the Smithsonian Instiution, the Ford Foundation, etc.

In addition to gratitude to Cornell University for essential funding, thanks are due to the South Asia Council of the Association for Asian Studies for a special allocation that has again supported mailings of announcements, calls for papers, and progress reports dealing with the association and especially the program of the annual meeting and conference in Wisconsin.

There was update discussion of the by-laws of the Nepal Studies Association which have not been amended since they were written in 1971. The executive committee will present proposed revision of the by-laws, but first the total board should be increased to nine persons, as required by 1971 rules. Current executive committee members are: Bernier, Pradhan, Holmberg, March, and Stone. Four additional members are needed and nominations from the floor are:

Richard Tucker, Paljor Tsarong, Jim Fisher, Judith Justice, Leo Rose, and Surya B. Prasai. Mary Slusser was nominated but later withdrew. **(Please send in the ballot in this issue).**

Correspondence from Nepal Studies Association members was summarized by the president and letters were read from James W. Stone (Foreign Service Institute, U.S. Department of State), Valworth R. Plumb (Duluth, Minnesota), Makoto Numata (Laboratory of Ecology, Chiba University, Japan), Robert M. West (Carnegie Museum of Natural History, Pittsburgh, Penn.), Gokey Dekhang (Library of Tibetan Works and Archives, Dharamsala, India), and Merrill Goodall (Claremont College, Calif.).

Dor Bahadur Bista briefly reported on growth of Asian Studies and Nepal Studies research at Tribhuvan University (including a special illustrated publication on Cangu Narayana temple).

Hugh B. Wood reported on continued progress of the American-Nepal Educational Foundation, with many grantees from Nepal in attendance at this meeting and two meetings scheduled, and he revealed that he will address students and faculty of Tribhuvan University at an important upcoming convocation in Nepal. Special films showing at the conference were also announced.

The author of Nepal Mandala, Mary Shepherd Slusser, was introduced to the gathering and all were reminded of the roundtable discussion of her book that is part of the Wisconsin conference program.

The question of re-naming the organization the Himalayan Studies Association was raised from the floor and briefly discussed, resulting in a plan to bring the matter to all the membership through the bulletin.

By unanimous vote it was decided to hold the 1984 meeting once again in Madison (Nov. 2-4, 1984).

Suggestions from the floor regarding the 1984 program and Himalayan subjects include: Problems of Land Usage with Jeannette Denholm as tentative chair, Economic Development in Nepal with R. Dwivedy as tentative chair, and a paper by Bishnu Bhandari on malnutrition among children in Nepal. A call for papers will appear in the bulletin.

The special dinner for those interested in Nepal was announced for the evening of Nov. 5 with Krishna Pradhan as coordinator and all present were urged to attend.

A special group discussion, Nepali "Gyana-Gushthi" arranged by Krishna Pradhan was announced for Nov. 5 afternoon.

The meeting was adjourned at 1:00 p.m.

***NEW EXECUTIVE DIRECTOR APPOINTED TO THE RESEARCH CENTER FOR NEPAL AND ASIAN STUDIES (CNAS).**

His Majesty the King, Chancellor of Tribhuvan University, granted the approval for the appointment of Kumar Khadga Bikram Shah as Executive Director of Research Centre for Nepal and Asian Studies subsequent to the petition from Vice-Chancellor.

Kumar Khadga Bikram Shah assumed the post of Executive Director on November 17, 1983.

Born in 1942 in Kathmandu, Mr. Shah had his early schooling at St. Xaviers, Godavari, where he completed Senior Cambridge in 1959. He then joined St. Xaviers, Calcutta and completed his Intermediate of Arts. He went on to do his Bachelor of Arts from Nepal National College and Bachelor of Law from Nepal Law College.

Mr. Shah was Member Secretary of the National Sports Council from 1967 to 1977. He was a fellow at the Centre for International Affairs, Harvard during 1979. He has written extensively on political affairs in the Himali Bela, the English daily.

At present Mr. Shah is also the Chairman of the Disaster Relief Committee of Red Cross and Member of the Social Services National Co-ordination Council.

Mr. Shah has been decorated by His Majesty the King with Gorkha Dakshin Bahu II and Tri Sakti Patta II.

Mr. Shah was married in 1966 and has three sons.

***PICTURE EXHIBITION ON TIBET**

A collection of old pictures of Tibet has been assembled as "Tibet: The Sacred Realm, 1880 - 1950." Taken by a variety of early Western travelers, many of these have not been published or exhibited previously. Of special interest are portraits and interiors of homes and monasteries, settings that are often decorated with fine Chinese, East Turkestan and Tibetan rugs. Several outdoor photographs show riders seated on saddle rugs, notably one of cavalry dressed in Mongolian style for the New Year's Festival in Shigatse (1907). The catalog reproduces many of the pictures, along with brief biographies of the photographers and a narrative text by Lobsang Lhalungpa.

The show first hangs at the Alfred Stieglitz Center of the Philadelphia Museum of Art (March 20-May 22), and will travel to the Institute for the Arts at Rice University in Houston (September 23-December 31) and to the Asia Society in New York (March 1-May 27, 1984).

***THE ZURICH CONFERENCE ON MOUNTAIN FOREST HISTORY**

Proposals are invited for papers to be presented at a conference on the history of forests in the mountain zones of the world, which will be held on September 3 - 7, 1984 in Zurich, Switzerland. Topics to be discussed will encompass the impact of human and livestock activity on the fragile forest and plant communities in mountain zones of all continents. They will include subsistence food production, grazing and forest products use; the relation of mountain forests to adjacent lowland regions, including the rise of commercial logging and its impact, and forestry policy and management; and national development policies' effects in recent years.

The conference will be sponsored by the Institut für Wald- und Holzforschung, ETH-Zentrum, CH-8092 Zurich, Switzerland, and the Forest History Group of the International Union of Forest Research Organizations. ***DR. HUGH WOOD ADDRESSES TRIBHUVAN UNIVERSITY CONVOCATION**

On invitation of Vice-Chancellor Ram Sundar B. Singh and Chancellor His Majesty King Birendra Bir Bikram Shah Dev, Dr. Hugh Wood, Executive Director of the American Nepal Education Foundation, delivered the convocation address for Tribhuvan University on December 9, 1983 — the Silver Anniversary year of the laying of the Corner Stone of the University. This was the first convocation held in four years, due to student disturbances; consequently there were more than 12,000 students ready to receive their diplomas. The Convocation was held in the Civic Stadium, the only structure in Nepal large enough to accommodate the large number of students and relatives.

While in Nepal, Dr. and Mrs. Wood conducted business relative to the Foundation and interviewed applicants for scholarship assistance.

***AN EXHIBIT ON THE ARCHITECTURE OF THE KATHMANDU VALLEY, WINTER 1984/85.**

Werkgroep Ganesh, under the auspices of Vereniging Nederland-Nepal, is organizing a travelling exhibition, to be held at several locations in the Winter of 1984/85.

The bulk of the material to be shown will consist of an introduction to the architecture of Nepal and particularly of the Kathmandu Valley, which was at its peak during the Malla period, when the kingdoms of Kathmandu, Bhaktapur and Patan arose. Ample visualizations and concise texts show the historical development, the social and ritual topography of these towns. Some of the specific subjects include building technique, windows and carpentry, palaces and dwellings, temples and stupas, daily life, festivals and rituals. Objects including carpenter's tools and materials, building fragments (windows), models, bronzes, thankas and masks, and musical instruments, and furniture will be in the display. Finally, the exhibit shows recent developments such as: palaces and villas from the Rana-epoch, recent architecture, suburbanization, traffic, changes in infrastructure, and restoration projects.
