ABOUT THE AUTHORS

Dr. Benedict R. Anderson is the Aaron L. Binenkorb Professor of International Studies at Cornell University and serves as Director of the Modern Indonesia Project and Editor of *Indonesia*. A renowned thinker on nationalism as well as a scholar of the politics of Indonesia and Thailand, Dr. Anderson has written, translated, and edited nearly 200 works, including *Java in a Time of Revolution* (1972); *Imagined Communities: Reflections on the Origin and Spread of Nationalism* (1983); *In the Mirror: Literature and Politics in Siam in the American Era* (1985); and *Language and Power: Exploring Political Cultures in Indonesia* (1990).

Dr. Seyla Benhabib is a Professor of Government at Harvard University and a Senior Research Fellow at Harvard's Center for European Studies. Recently she was a Visiting Senior Fellow at the Institute for Human Sciences in Vienna, Austria. A native of Istanbul, Turkey, she has served on the editorial boards of various academic journals. Among her many publications are *Critique, Norm and Utopia: A Study of the Foundations of Critical Theory* (1986), *Situating the Self: Gender, Community and Postmodernism in Contemporary Ethics* (1993), and *Feminist Contentions: A Philosophical Exchange* (1996).

Dr. Emmanuel Sivan is a Professor of History at Hebrew University in Jerusalem, Israel. A three-time Distinguished Visiting Professor at Rutgers University and former Publisher and Editor of *The Jerusalem Quarterly*, Dr. Sivan has written and edited eight books and over thirty articles. His works include *L'Islam et la Croisade* (1968); *Interpretations of Islam* (1985); *Jewish & Islamic Political Extremism* (1990); and *The 1948 Generation: Myth*, *Demography*, *Memory* (1991).

Alberto Moya Monge is a senior at Macalester College majoring in Communication Studies and International Studies. A native of San José, Costa Rica, he has taught English as a second language to Latino immigrants and has worked with local television stations gathering information and breaking news via satellite video transmissions. He has published twelve books and nearly four dozen articles, including "The October War: Changes in Cognitive Orientation Toward the Middle East Conflict" (1979), Reading the Postmodern Polity: Political Theory as Textual Practice (1992), Challenging Boundaries: Global Flows, Territorial Identities (1996), and Violent Cartographies (1997).

Dr. Jean Comaroff is the Bernard E. and Ellen C. Sunny Distinguished Service Professor of Anthropology at the University of Chicago. She is the author of several books and more than two dozen scholarly articles. Her major publications include *Body of Power, Spirit of Resistance: The Culture and History of a South African People* (1985); *Of Revelation and Revolution: Christianity and Colonialism in South Africa* (1991); and *Ethnography and the Historical Imagination* (1992). In addition, Dr. Comaroff is a member of the editorial boards of several leading academic journals.

Minh Ta, a senior at Macalester College, was born in Saigon, Vietnam, and grew up in Philadelphia. A former vice president of the Macalester College Student Government and active community member, he is completing majors in Political Science and History. His academic interests include issues of race construction and public policy.

Dr. Nandy has written a number of engaging works, including *At the Edge of Psychology: Essays in Politics and Culture* (1980); *Traditions, Tyranny, and Utopias: Essays in the Politics of Awareness* (1987); *Science, Hegemony, and Violence: A Requiem for Modernity* (1990); and, most recently, *The Savage Freud and Other Essays on Possible and Retrievable Selves* (1995).
