## ABOUT THE AUTHORS

**Keith Griffin**, Distinguished Professor of Economics at the University of California at Riverside and former president of the Magdalen College at Oxford University, is an expert in development economics. A leader of many ILO and UNDP missions, including ones to Kazakhstan, Vietnam, Ecuador, and Mongolia, he has also served as an adviser to the OECD Development Center in Paris, the USAID, the Inter-American Committee for the Alliance for Progress, and the government of Bolivia. His more than 25 books and monographs and numerous articles include *World Hunger and the World Economy* (1987), *Globalization and the Developing World* (1992), *Studies in Globalization and Economic Transition* (1996), "Globalization and Development Cooperation: A Reformer's Agenda" (1997), and *Economic Reform in Vietnam* (1998).

**Saskia Sassen** is a Professor of Sociology at the University of Chicago. Her most recent books are *Globalization and its Discontents* (New York: New Press, 1998) and *Losing Control? Sovereignty in an Age of Globalization* (Columbia University Press, 1996). Several translations of her book *The Global City* are appearing, among them French (Descartes, Paris, 1996), Italian (UTET, Milano, 1997), and Spanish (UBA, Buenos Aires, 1998). She is currently completing *Immigration Policy in the Global Economy: From National Crisis to Multilateral Management*, sponsored by the Twentieth Century Fund, and has begun a new project on "Cities and their Crossborder Networks," sponsored by the United Nations University. She is a Fellow of the World Economic Forum and a member of the Council on Foreign Relations.

**Sarah Stucky** is a senior at Macalester College, majoring in Political Science and concentrating in Economics. Combining these two academic interests took her to Colombia for Spring Semester, 1998, where she studied the politics and practices of lending to the proprietors of microenterprises. Upon graduation, Sarah will pursue a Ph.D. in Political Science, focusing especially on Latin America.

**Thandika Mkandawire** is the current Director of the United Nations Research Institute of Social Development (UNRISD) in Geneva and former executive secretary of the Council for the Development of Social Science in Africa (CODRESIA). The recipient of the Distinguished 50<sup>th</sup> Anniversary Fulbright Fellowship, he has published extensively on the political economy of adjustment and is currently working on problems of economic policy-making and democratization in Africa. His works include *Structural Adjustment and Agrarian Crisis in Africa* (1989), "Stylising Accumulation in Africa: The Role of the State" (1995), "Fiscal Structure, State Contraction and Political Responses in Africa" (1996) and *Beyond Crisis: Towards Democratic Developmental States in Africa* (forthcoming).

**Meredith Woo-Cumings** is an Associate Professor of Political Science and the Director of the Roundtable on Political Economy at Northwestern University. She specializes in comparative politics and political economy, with an emphasis on East Asia. In 1996, she was appointed by President Clinton to serve on the Presidential Commission on U.S.-Pacific Trade and Investment Policy. She has authored/edited four books and nearly two dozen articles, including *Race to the Swift: State and Finance in Korean Industrialization* (1991), *Past as Prelude: History in the Making of the New World Order* (1991), *Ungoverning Capital* (1996), and *The Developmental State* (1999).
