ABOUT THE AUTHORS

Franklin Hugh Adler is the G. Theodore Mitau Professor of Political Science at Macalester College. Recipient of numerous awards and fellowships, he is the author of *Italian Industrialists from Liberalism to Fascism* (1995). Dr. Adler is a specialist in political theory and comparative European politics. His essays have appeared in scholarly journals on both sides of the Atlantic, including *American Journal of Political Science, Perspectives in Politics, Ethics, Telos, Contemporary Sociology, Patterns of Prejudice, Les Temps Modernes, Raisons Politiques, and Il Ponte.* He also contributed to the Routledge four-volume collection of essays on Antonio Gramsci as well as anthologies on Fascism and social movements of the Left and Right. In addition, he edited a special issue of *Telos* on Italian Fascism and another special section on the Fascist racial laws and Italian intellectuals.

Dr. Adler is currently working on a book about Italian Jews and Fascism, having published a number of critical essays during the past four years in English, French, and Italian journals ("Why Mussolini Turned on the Jews," *Patterns of Prejudice*; "Italian Jews and Fascism," *Telos*; "Mirella Serri, Fascism and Redeemed Intellectuals," *Telos*; and "Jew as Bourgeois, Jew as Enemy, Jew as Victim of Fascism," *Modern Judaism*, forthcoming).

Terry Boychuk, associate professor and chair of Sociology, took his graduate studies at Princeton University and lectured in the Center for Health Policy Research and Education at Duke University before joining the Macalester faculty in the Sociology Department in 1996. He has taught a broad spectrum of courses on health care issues ranging from health policy and politics, to the historical transformation of health care professions, institutions, and markets, to the sociology of health and illness. His most recent publication, *The Making and Meaning of Hospital Policy in the United States and Canada*, is an imprint of the University of Michigan Press.

Juan R. I. Cole is Richard P. Mitchell Collegiate Professor of History at the University of Michigan. He has authored, translated, or edited fifteen books, most recently *Engaging the Muslim World* (Palgrave Macmillan, March 2009). He is also author of *Napoleon's Egypt: Invading the Middle East* (Palgrave Macmillan, 2007) and *Sacred Space and Holy War: The Politics, Culture and History of Shi'ite Islam* (I.B. Tauris, 2002). He is past president of the Middle East Studies Association.

The Rev. Dr. Lucy Forster-Smith has served Macalester College as its Chaplain since 1994. She graduated from Princeton Theological Seminary with a Master of Divinity degree in 1979 and was ordained as a Presbyterian Church (U.S.A.) minister in 1980. In 2001, she completed her Doctor of Ministry degree at Princeton Theological Seminary.

Prior to joining Macalester, Rev. Forster-Smith served on campuses in Washington state, Wisconsin, and Ohio. She is the author of many articles in journals, including *Theology Today*, *The Presbyterian Outlook*, and *Church and Society*, as well as religious educational resources published by Westminster/John Knox Press. In addition to her responsibilities as Chaplain, Rev. Forster-Smith serves as Co-Director of Macalester's Lilly Project for Vocation and Ethical Leadership, which is a program of the Institute for Global Citizenship.

Olga González is an assistant professor in the Department of Anthropology at Macalester College. She received her Ph.D. at Columbia University in 2007. She was awarded a grant from the Wenner-Gren Foundation for Anthropological Research to do an ethnographic study on memory and visual representations of violence in the highlands of Peru, which was the basis for her dissertation and book manuscript titled, "Unveiling Secrets of War in the Peruvian Andes" (under contract with University of Chicago Press). She was also the advisor for two traveling art exhibits in the United States, "Weavings of War" and "Ayacucho: Tradition and Crisis in Peruvian Popular Art." In Peru, she worked as a clinical psychologist and executive director of a non-governmental organization that developed psychosocial programs for grassroots communities.

William B. Quandt joined the Department of Politics at the University of Virginia in 1994, where he holds the Edward R. Stettinius Chair. From 2000 to 2003, he served as Vice Provost for International Affairs at the University. Prior to this appointment, he was a Senior Fellow in the Foreign Policy Studies Program at the Brookings Institution, where he conducted research on the Middle East, American policy toward the Arab-Israeli conflict, and energy policy.

Before joining Brookings in 1979, Dr. Quandt served as a staff member on the National Security Council (1972–1974, 1977–1979). He was actively involved in the negotiations that led to the Camp David Accords and the Egyptian-Israeli Peace Treaty. Dr. Quandt was also an Associate Professor of Political Science at the University of Pennsylvania, worked at the Rand Corporation in the Department of Social Science from 1968–1972, and taught at UCLA and MIT.

His books include *Peace Process: American Diplomacy and the Arab-Israeli Conflict Since* 1967 (2005, 3rd ed.); *The United States and Egypt: An Essay on Policy for the* 1990s (1990); *Camp David: Peacemaking and Politics* (1986); and *Decade of Decisions: American Foreign Policy Toward the Arab-Israeli Conflict,* 1967–1976 (1977). He also edited *The Middle East: Ten Years After Camp David* (1988).

Dr. Quandt is a member of the Council on Foreign Relations and serves on the Board of Trustees of the American University in Cairo and the Foundation for Middle East Peace. He was elected to the American Academy of Arts and Sciences in 2004.

Thomas M. Ricks is an independent scholar of the social and cultural history of Iran and Palestine. After two years in Iran as a Peace Corps volunteer, he completed both an M.A. degree in Persian Language and Literature and a Ph.D. in Middle East History at Indiana University, before spending the next thirty years (1975–2005) teaching and researching at Macalester College, Georgetown (Washington, D.C.), Birzeit University (Ramallah, occupied Palestine), Villanova, and the University of Pennsylvania.

He has completed works on Iranian literature and society (*Literature of Contemporary Iran* and *Critical Perspectives on Modern Persian Literature*) and on Palestinian social and cultural history (co-authored *The Oral History of the Palestinian Intifada*). He also edited the diaries and testimonies of a Palestinian educator, *Eyewitness to Turbulent Times: Khalil Totah of Ramallah, Palestine*—1886–1955. Dr. Ricks is presently completing an oral history monograph on Palestinian schools during the British Mandate, entitled, *Voices from the Schoolyard: Memories of Palestine, School Days and Mission Education.*

Khaldoun Samman was born in Zarqa, Jordan, but moved to the United States at a young age. He received his B.A. from George Washington University in Washington, D.C., and earned his Ph.D. at Binghamton University in New York. His book, *Cities of God and Nationalism: Mecca, Jerusalem and Rome as Contested World Cities*, was released in 2007. He is currently completing a book manuscript entitled, *The Clash of Modernities: The Islamist Challenge and the Making and Unmaking of the "New" Jew, Turk, and Arab* (forthcoming in July 2009). He also co-edited a volume with Mazher Al-Zo'by, *Islam and the Orientalist World-System*

(2008). Dr. Samman is an associate professor of sociology at Macalester College, where he teaches a wide variety of courses that range from Social Theory to Islam and the West. His special fields of interest include world-systems analysis, the sociology of religion, historical/ comparative sociology, and social theory.

Avraham Sela earned his Ph.D. from Hebrew University of Jerusalem in 1987, where he is currently a Senior Lecturer in the Department of International Relations and a research fellow of the Harry S. Truman Institute for the Advancement of Peace. He has also held Visiting Fellowships at Princeton University (1987–1988) and Oxford University (2000–2001), as well as Visiting Professorships at the University of Waterloo, Ontario (1995), the Middle East Technical University, Ankara (1999), and other universities throughout the United States.

Prior to joining the Hebrew University faculty, Dr. Sela served as a career officer in the research division of the Israeli Defense Forces Intelligence Branch (1970–1986), during which time he took part in the late-1970s Israeli-Egyptian peace talks and the mid-1980s Israeli-Lebanese military talks. In his academic career, Dr. Sela was the recipient of the Yigal Alon Fellowship of Israel's Council for Higher Education (1988). His main fields of research are inter-Arab politics and the Arab-Israeli conflict, as well as contemporary Palestinian society and politics.

Dr. Sela has authored several works, including *The Decline of the Arab-Israeli Conflict: Middle East Politics and the Quest for Regional Order* (1998) and *The Continuum Political Encyclopedia of the Middle East* (2002). He co-authored *The Palestinian Hamas: Vision, Violence and Coexistence* (2nd ed., 2006) with Shaul Mishal.

Abdelrahman Tamimi works in the field of water resources in the Occupied Palestinian Territories. During the past seventeen years, his activities have focused on social and environmental conflicts, water security, and water resources management and planning at the regional and national levels. He participated in crafting the negotiation strategy for the Palestinian delegation in the multi-lateral talks in addition to participating in all of the rounds of negotiations. Furthermore, he has been the coordinator of many international research projects dealing with hydrogeology, hydrochemistry, water policy, and water resources planning. Recently appointed as a member of the National Water Council and the National Reform Committee, his current occu-

pation is Director of the Palestinian Hydrology Group and lecturer at Al-Quds University.

Wendy Weber is a Visiting Instructor in the Political Science Department at Macalester College, where she teaches courses on International Politics, Global Governance, Gender and International Relations, and Humanitarianism. She is also a member of the Steering Committee for the College's Program in Human Rights and Humanitarianism. She earned her B.A. and M.A. at the University of Manitoba in Canada. Her main academic interests are in changing patterns of global governance, especially in the areas of human rights and humanitarianism.

Chuen-Fung Wong, assistant professor, teaches world music and ethnomusicology at Macalester College. His research focuses on music and minority nationalism, with particular interest in the musical traditions of the Uyghur people (Central Asian Turks) in northwest China. He is the editor and co-author of *Listening to Chinese Music* (Hong Kong: Commercial Press, 2009).
