Philip Alston is the John Norton Pomeroy Professor of Law, New York University School of Law. From 2004 to 2010 the author was United Nations Special Rapporteur on Extrajudicial, Summary or Arbitrary Executions, and in that capacity reported regularly to both the U.N. Human Rights Council and the U.N. General Assembly.

Ron Barrett is a professor of Anthropology at Macalester College and teaches courses in medical anthropology, cultural anthropology, emerging infections, and the anthropology of death and dying. He has conducted fieldwork in Northern and Western India as well as in the United States. His book, *Aghor Medicine: Pollution, Death, and Healing in Northern India* (2008), was awarded the Wellcome Medal for medical anthropology by the Royal Anthropological Institute.
